

**CONTRACT OF EMPLOYMENT BETWEEN
[REDACTED] AND THE BRAINTREE PUBLIC SCHOOLS**

**ADDENDUM
INTERIM SUPERINTENDENT APPOINTMENT**

THIS AGREEMENT (hereinafter referred to as the “Employment Contract”) is made and entered into by and between the **BRAINTREE SCHOOL COMMITTEE** (hereinafter, the “Committee”), whose members act hereunder in their representative capacity only and without any personal liability to themselves, and [REDACTED] (hereinafter, the “Interim Superintendent”) of [REDACTED] Massachusetts.

WHEREAS, [REDACTED] is currently employed as the Assistant Superintendent and has a subsequent contract with the Superintendent of Schools for the period of July 1, 2021 through July 1, 2024;

WHEREAS, the School Committee voted to appoint [REDACTED] as Interim Superintendent effective July 1, 2021; and,

WHEREAS, the Parties wish to describe the terms and conditions of such appointment;

NOW, THEREFORE, in consideration of the promises herein contained, the Parties hereto mutually agree as follows:

1. During the period of his appointment as Interim Superintendent, [REDACTED] shall perform the duties and responsibilities of Superintendent.
2. During the period of his appointment as Interim Superintendent from July 1, 2021 through June 30, 2022, he shall be compensated based upon an annual salary of \$190,000, pro-rated for that portion of the year actually worked as Interim Superintendent. The term annual, as used herein, shall mean the year commencing July 1 and ending June 30. If requested to perform any duties as Superintendent prior to July 1, 2021, he will be paid on a pro-rata basis.
3. Beginning on July 1, 2022, [REDACTED] revert to his former position as Assistant Superintendent. The terms of his Assistant Superintendent contract, paragraph two are herein modified to change the period from July 1, 2022 through June 30, 2025. Beginning July 1, 2022, his salary as Assistant Superintendent shall be \$170,094.
4. If the Committee appoints a new Superintendent prior to July 1, 2022, [REDACTED] shall continue to serve in the role as Interim Superintendent until June 30, 2022, unless the parties mutually agree to different date for him to return to his former position as Assistant Superintendent.
5. The Assistant Superintendent Contract paragraph 18 shall be amended to require a minimum of ninety (90) days’ notice, if he seeks to terminate his contract.

6. All other terms and conditions of the Assistant Superintendent contract entered into in December 2020, shall remain in full force and effect, except as expressly modified herein.
