Please note that Codman Academy will not be able to employ individuals who refuse to provide the information necessary or meet the minimum requirements for their role. You are required to return any material entrusted or loaned to you immediately upon termination of your employment.

Your employment is subject to Codman's financial condition, enrollment, programmatic changes, fulfilling the responsibilities of your position, and maintaining satisfactory performance, conduct, and professionalism, as determined by Codman Academy leadership. No contractual obligations exist between Codman Academy and you.

In case any provision of this agreement shall be invalid, illegal or otherwise unenforceable, the validity, legality and enforceability of the remaining provisions shall in no way be affected or impaired thereby. The resolution of any disputes under this letter will be governed by Massachusetts law.
