ADMINISTRATOR CONTRACT

This contract made as of **July 1**, **2017** by and between the Franklin County Technical School District Committee, hereinafter referred to as the Committee, and

Assistant Principal/Dean of Students

In consideration of the promise herein contained, the parties mutually agree as follows:

- 1. TERM ... A one year contract commencing July 1, 2017 and ending June 30, 2018, consisting of 185 working days that coincide with the school calendar plus 20 additional days. The principal shall notify the administrator at least sixty (60) calendar days prior to June 30, 2018 of his intent to terminate or extend the contract past the stated expiration date.
- 2. COMPENSATION ... The salary for the fiscal year beginning July 1, 2017 and ending June 30, 2018 will be \$92,710.00, plus a \$2,300.00 longevity payment, for a total of \$95,010.00.
- 3. DUTIES ... As outlined in the position description for Assistant Principal/Dean of Students.
- 4. REIMBURSEMENT FOR EXPENSES ... As outlined in Administrators Personnel handbook.
- 5. FRINGE BENEFITS ... All hospitalization insurance, medical insurance, life insurance, sabbatical leave, and retirement benefits shall be based upon the practices and contribution ratios as defined in the current Administrators Personnel Handbook.
- 6. SICK LEAVE ... The Administrator will be granted sick leave with full pay for fifteen (15) working days per fiscal year. The Assistant Principal/Dean of Students can be a member of the Staff Sick Leave Bank.
- 7. TERMINATION ... This contract and the obligations and liabilities of the parties hereto during the term of this contract shall terminate upon the occurrence of any of the following:
 - A. Dismissal of the Assistant Principal/Dean of Students in accordance with Chapter 71, of the General Laws;
 - B. The mutual agreement of the parties hereto; or
 - C. The Assistant Principal/Dean of Students may terminate this agreement or his employment upon 90 days notice to the Superintendent-Director.

Failure to sign and return this Contract to the Office of the Superintendent within ten (10) calendar days after being issued and received will render this Contract null and void.
